Overview - Where are we now?

Transition period

- Continuity (exceptions relating to UK representation in EU institutions)
- EU law still applies

- (Extension)
- Limited deal
- No deal

- Alignment of standards

Commission - bridging mechanism

Adequacy decision

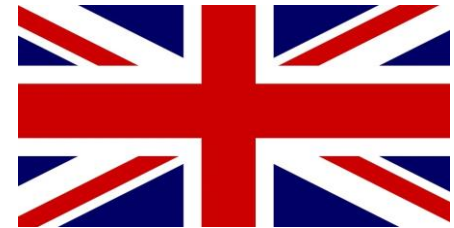
- Proposal - Commission
- Opinion – EDPB
- Approval of member states
- Adoption by Commission



Overview - domestic view

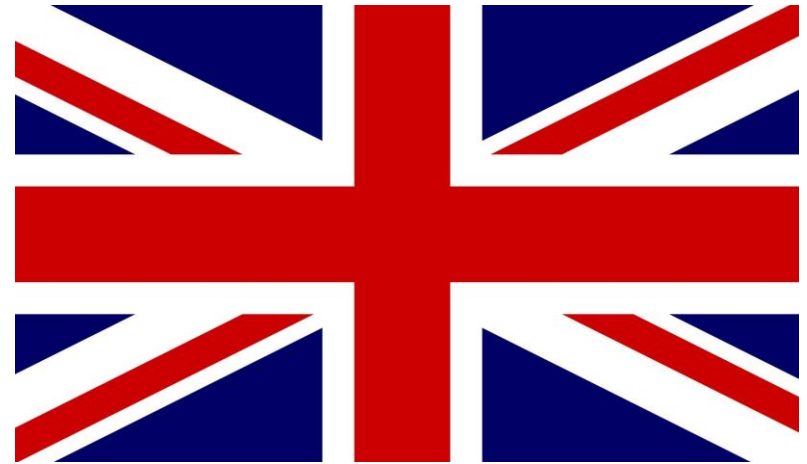
End of transition period

- EU law saved
- Turned into domestic law
- Retained EU law

Application of UK GDPR

- Article 3 GDPR
- Established in UK
- Extra-territorial scope



Divergence

- UK GDPR
- EU GDPR



Practical implications - adequacy

- No change – free flow of data
- Appoint EU/UK representatives
- Update contracts, policies and procedures
- Monitor divergence (international transfers mechanisms/case law/guidance/recommendations)



Practical implications - extension

- No change - free flow of data
- Update contracts, policies and procedures



Practical implications – no adequacy



- Appropriate safeguards
- Standard contractual clauses (transfer impact assessment/supplementary measures)
- Update contracts, policies and procedures
- Appoint EU/UK representatives
- Monitor divergence (international transfers mechanisms/case law/guidance/recommendations)

Future developments

- Divergence between UK and EU regimes
- Challenge to UK adequacy?
